Who paid out of pocket



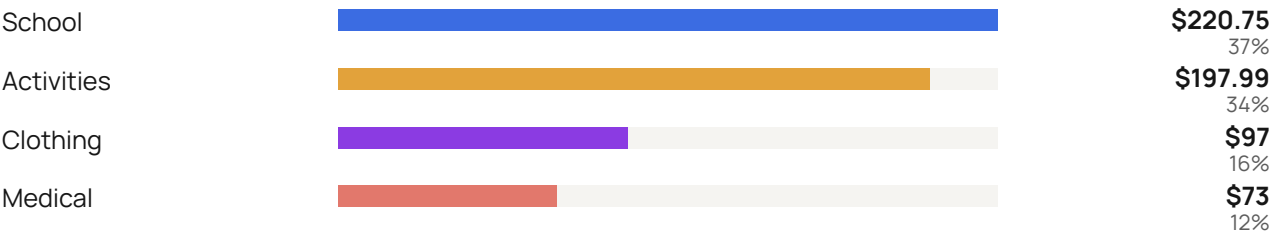

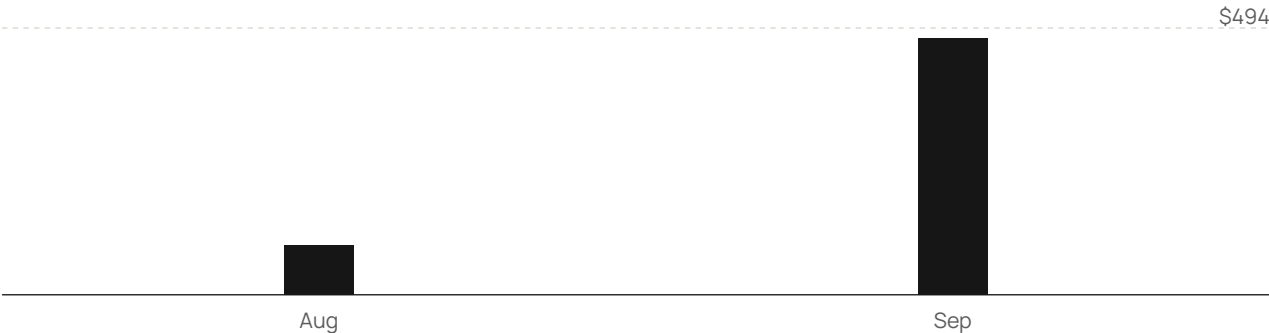
